- 25/7 Matters Arising from the previous meeting (non-decision making)
 - Speeding Cllr Walker reported that a DHL van had been speeding up Park Lane today and this has been reported to DHL and will be reported to the police.
- 25/8 New Parish Council Website Cllr Leeney reported the website was finished and looks good. The Councillors and the Clerk will put their profiles on the site. The domain is a .gov.uk one which falls in line with the website requirements for Parish Council's. Cllrs Leeney, Walker and the Clerk have been trained.

Thanks were given to Cllr Leeney for organising the website.

- 25/9 Park Lane Repairs There is damage to the layby on Park Lane. Cllr Leeney will look into obtaining chatter to fill the holes. Cllr Taylor noted that the hedging and undergrowth is in poor condition and overgrown. Hall Lane is also in poor state. It was noted that the hedge wasn't at the level of impacting road safety so could not be cut back at this time of the year.
- 25/10 Defibrillator Cllr Walker reported that the Defib is out of action and the battery should be arriving in a few days. EMAS declared it out of action. It was noted that it hasn't been checked since 2021 which was when the battery was last changed. The person who was checking it is no longer doing so. Cllrs Leeney and Walker will register the machine and Cllr Leeney will start doing the checks on behalf of the Parish Council. It was agreed to look at replacing the defib in 4 years when the battery expires.

In the middle of January there were 3 incidents of attempted car break-ins.

Those involved used the Village WhatsApp group to inform residents immediately.

I contacted PC B Bradbury who replied and visited the addresses of those involved.

It seems that the police have described the attempts as keyless car thefts, though very little or nothing was taken.

Discussion on the Village WhatsApp group followed. There were several products recommended that might prevent the same thing happening again.

I have yet to start looking for a replacement. If I cannot find someone to take over, then I may have to dissolve the NHW scheme for Shirley.

- Drains and Hedges Mill Lane drains are still not cleared and there is one near the Mount that appears to have collapsed. The Clerk will report these again. It was noted that they won't be repaired without flooding. Photos will be taken and sent to Clr Bull (DCC)
- Speedwatch It was noted that volunteers are still needed. There is a problem with cars coming from Hollington speeding.
- 25/14 Pot Holes Cllr Crabtree reported there are a lot of smaller ones but nothing really reportable. There is one on Park Lane and two more on Park Lane have been reported. Cllr Bull (DCC) will report them. There is also two on Derby Lane that were repaired but opening up again.
